This time, we have transferred the shares of ADLER SOLAR WORKS Co., Ltd. (hereinafter referred to as "ASW"), an enterprise owned by the fund operated by the JIA Group, as described below.

1. Purpose of shares transfer

The JIA Group invested in ASW, which has the experience of operation and maintenance (O&M) of solar power plants, in 2021 by utilizing the knowledge of solar power generation business, which has been operated since 2014. We have improved the value of ASW through the business alliance for the O&M of solar power plants managed by our company.

This time, we have decided to transfer the shares of ASW, so that ASW will be able to enhance its corporate value further through the capital alliance with an enterprise that could generate more synergetic effects with ASW.

*O&M stands for operation and maintenance, which are conducted after the installation of a variety of equipment, including solar power generators.
