#### 1. Purpose of the investment

RIVERFIELD was established in 2014 as a venture firm originating from a national university. Since 2003, they have been researching the development of robots at laboratories in mainly the Tokyo Institute of Technology and Tokyo Medical and Dental University.

RIVERFIELD provides the following medical robots that are not only precise, but also have a soft texture like the human hand.

#### [Typical Products]

- ➤ "Saroa," the world's first pneumatically-driven robot for holding an endoscope, and its compact type "IvyA1"
- > "OQrimo," a robot for supporting eye surgery with the function to directly observe the inside of the eye
- > "EMARO," an endoscope holding robot that can be operated intuitively by a surgeon with the head sensor function

In addition to their track record, the JIA Group agreed with RIVERFIELD's corporate philosophy of "solving social issues and creating new value with the technologies nurtured in college laboratories," which is intended for settling social issues with the capabilities of robots while putting importance on the public nature and public benefits of their business. Accordingly, the JIA Group has decided to acquire the shares of RIVERFIELD to support the growth of their business.
