erex Co., Ltd. (hereinafter referred to as the Coompany) hereby announces that HIKARI TSUSHIN, INC. (hereinafter referred to as HIKARI TSUSHIN) became an other affiliated company as of June 6, 2025, as described below.

1. Background Leading to the Change

The Company has confirmed that the total ownership ratio of voting rights in the Company indirectly owned by HIKARI TSUSHIN's joint ownership (Hikari Tsushin, UH Partners 3 Inc., UH5 Inc., Sakura Insurance Inc., and Hikari Tsushin Investments Asia Private Limited) has exceeded 20%. Hikari Tsushin Investments Asia Private Limited) through its subsidiaries, has exceeded 20% in the report of changes submitted on June 13, 2025. Subsequently, HIKARI TSUSHIN formally informed the Company that HIKARI TSUSHIN applies the equity method to the Company and requested the Company regarding practical matters related to the delivery of financial statements, resulting in HIKARI TSUSHIN being the Company's other affiliated company.
